(Regardless of vaccination status)



I HAVE SYMPTOMS OF COVID-19  
(Regardless of vaccinations status)



I WAS IN CLOSE CONTACT\* WITH SOMEONE DIAGNOSED WITH COVID-19  
**And have been:**

- Fully vaccinated with Pfizer or Moderna, but it was over 6 months ago and I am **not boosted**
- OR
- Fully vaccinated with J&J, but it was over 2 months ago and I am **not boosted**
- OR
- I am **Unvaccinated**



I WAS EXPOSED TO COVID-19  
**And have been:**

- Fully Vaccinated and boosted
- OR
- Fully Vaccinated (Pfizer / Moderna) in last 6 months
- OR
- Fully vaccinated (J&J) in the last 2 months



- Do not come to campus. If you are on campus, immediately go home. Students in dormitories should be prepared to return home to primary residence during this time.
- Complete EGSC Self-Reporting form (yellow header at the top of the EGSC website). The EGSC COVID-19 Response Team will contact you for further guidance.
- Do not return to campus until you receive clearance from the EGSC COVID-19 Response Team.

**Students:** Contact your healthcare provider or Student Health Services by phone for guidance. Inform your faculty of needed absence.

**Employees:** Contact your healthcare provider by phone for guidance. Inform your supervisor of needed absence.

**General Guidelines:**

- Stay home for 5 days.
- If you have no symptoms or your symptoms are resolving after 5 days, you may return to campus **if cleared** by EGSC COVID-19 Response Team.
- Continue to wear a mask around others for 5 additional days.

**IMPORTANT:** A negative test result does not automatically allow you to return to campus. You must follow the guidance from the COVID-19 Response Team regarding return to campus.

- You may go to campus.
- You are strongly encouraged to wear a face covering around others for 10 days.

**IF YOU DEVELOP SYMPTOMS:**

- Do not come to campus. If you are on campus, immediately go home. Students in dormitories should be prepared to return home to primary residence during this time.
- Complete EGSC Self-Reporting form (yellow header at the top of the EGSC website). The EGSC COVID-19 Response Team will contact you for further guidance.
- Do not return to campus until you receive clearance from the EGSC COVID-19 Response Team.

\* Close contact: Within 6 feet of an infected person **for a cumulative total of 15 minutes or more over a 24-hour period starting from 2 days before illness onset** (or, for asymptomatic persons, 2 days prior to test specimen collection) until the time the person is isolated.
