

## East Georgia State College SENIOR CITIZEN WAIVER

According to the provisions of Amendment 23 to the Georgia Constitution, the Board of Regents of the University System of Georgia established the following to accommodate the enrollment of senior adults in system schools without the payment of fees, subject to the following conditions:

- Must be a legal resident of the State of Georgia.
- Must be 62 years of age or older and present proof of age at the time of registration.
- Must meet all other USG or institutional admissions requirements; however, the institution may exercise discretion in exceptional cases where circumstances indicate that certain requirements such as high school graduation and minimum test scores are in appropriate. In those instances involving discretionary admission, the institution will provide diagnostic methods to determine whether or not participation in Learning Support will be required prior to enrollment in regular credit courses. Reasonable prerequisites may be required in certain courses.
- May enroll as regular or auditing student and may take courses on a *space available* basis.
- Must be prepared to pay for supplies and/or lab/shop fees.
- Must meet all USG, institution or legislative degree requirements if degree-seeking.
- Must <u>not</u> enroll in dental, veterinary, medical (including nursing) or law school programs under the provisions of this policy.

Waivers should be submitted to the institution prior to the first day of classes for the term which the student seeks to register but must be received <u>no later than</u> the fee payment deadline for the term for which the student is registered.
